OVERVIEW OF TRANSITIONAL JUSTICE EXPERIENCE: ZIMBABWE

- I have worked in the field of transitional justice since 1995. I was the primary author and sole
 researcher of the very first transitional justice report written in Zimbabwe, which recorded the
 massacres of the post-independence 'Gukurahundi era'. This report was released by the Catholic
 Commission for Justice and Peace and the Legal Resources Foundation, entitled *Breaking the
 Silence, Building True Peace: A Report on the Disturbances in Matabeleland and the Midlands
 1982-1988.* An estimated 20,000 civilians died in regionally targeted massacres in the western
 provinces of Zimbabwe between 1982 and 1987. This report remains the primary document of this
 era, and the first to make recommendations on how to repair the past in Zimbabwe.
- As a **clinical psychologist**, much of my work has been longitudinal engagement with affected, very rural, communities, pioneering peace-building and healing processes for victims and survivors. The Zimbabwean political situation remains repressive, and much of the work happens quietly, with the support of grassroot traditional structures, including Chiefs, and families of those murdered.
- As a qualified forensic anthropologist, I have trained a team of colleagues and we have been exhuming victims of extrajudicial killings for purposes of respectful reburial since 1999 until the present. This programme developed out of a recognition that in terms of local beliefs in the importance of the ancestors, we needed to 'heal the dead' to heal the living: this meant removing the remains from shallow graves in the forests and reburying the properly identified human remains in the right place, with the right rituals, with the right people in attendance. Our work with exhumations has facilitated the basic *right to truth, the right to know* and the *right to mourn* for communities where these killings are still basically denied by the state.
- I have also played a longitudinal role in **working with victims of more recent political torture** since 2000. I have provided rehabilitative services, documentation and reports on this.
- Through working with affected families, I have also written six major reports on the impacts of state-orchestrated demolitions in Zimbabwe in 2005, (known as 'Murambatsvina', or 'get rid of the filth') that resulted in 500,000 urban citizens losing their homes and livelihoods in the space of two months. I have tracked some of the same families for more than a decade, to document the longterm impact of families being driven into abject poverty by deliberate state action, at a key point in their lives.

GLOBAL PARTNERSHIPS and EXPERIENCE OF TRANSITIONAL JUSTICE

- I have been hosted as a consultant or partner by NGO and INGO programmes working on the frontline of human rights and TJ issues
 - o In Latin America: Guatemala, Honduras, Argentina, Colombia
 - o In Asia: Sri Lanka, Bangladesh
 - o In Africa: South Africa, Kenya, Uganda, Liberia
- I have worked with the International Committee for the Red Cross (ICRC), including as a consultant compiling a report for them on their conference in Bosnia in 2019. This focused on family support groups for the disappeared globally.
- I have worked closely, including in the field, with the Argentine Forensic Anthropology Team and the South African Missing Persons Task Team.
- I continue to work closely with the African Union, through Redress in London, to develop guidelines that all African countries should abide by, in relation to prevention and resolution of enforced disappearances on the continent. These guidelines should be presented to the full AU during 2021.
- Through initial facilitation of Swiss Peace, we have over the last six years successfully externalized and digitally archived our large collection of documents and artefacts related to political violence in Zimbabwe. This work continues.
- Several consultancies mapping conflict and effectiveness of peace-building, including a 2015-2017 project in South Africa, 'combatting drivers of xenophobic violence' in 16 municipalities.

- Extensive facilitation experience, formal and informal, with civic society personnel, grassroots community members, health care professionals in relation to all aspects of Transitional Justice, including working ethically with victims, security of information, and accountability in repressive contexts.

- Fifteen years' experience, in training others in research methods, and archiving, within our own organisation and training of staff of other civic organisations in Zimbabwe.
